I understand that Special Olympics World Games Los Angeles 2015 (LA2015) may refuse to allow me to volunteer if I provided any incorrect information or omission, and that once I submit this application, I must notify LA2015 staff within fifteen days if I am charged or convicted of a criminal offense.

I understand that I will be using the facilities at my own risk and I, on my own behalf, hereby release, discharge, indemnify and hold harmless LA2015 from all liability for injury or accident to person or damage to my property.

I understand that LA2015 may, in its sole discretion, decline to accept my application for volunteering with or without cause. I also understand that, if selected, my volunteer service is an “at will” arrangement that can be modified or terminated with or without notice or cause, at any time, at the option of LA2015 or at my option.

I grant LA2015 and Special Olympics, Inc. (SOI) permission to use my likeness, voice, and words in or on television, radio, film, and on LA2015 and SOI’s websites, or in any other form, format, or media, to promote Special Olympics and its mission and to raise funds for Special Olympics.

If selected as a volunteer, in the course of volunteering for LA2015, I may be dealing with or have access to confidential information regarding athletes and volunteers’ contact information, date of birth, social security number, health, behavior and other personal information and I agree to keep said information in the strictest confidence.

I understand that this form indicates that I am interested in volunteering with LA2015, which means that I will work closely with the athletes, coaches, parents, guardians, LA2015 employees and staff, and other LA2015 volunteers. Upon submission of this form, I understand that LA2015 will take my application under review and, if my application is approved, LA2015 will conduct an in-person interview. I understand that LA2015 may request or conduct an extensive background

check. If I am selected as a volunteer, I understand that I will undergo a series of in-person on-site trainings to prepare me for my volunteer duties with LA2015.

I give LA2015 permission to request a background check report that discloses any criminal convictions, any pending arrests for which I am out on bail or on my own recognizance pending trial, any listing as an excluded individual or registered sex offender, or other information requested by LA2015 to determine my suitability as a volunteer. I also give LA2015 permission to obtain information relating to my motor vehicle driving record. I understand that this information will be used, in part, to determine my suitability for a volunteer position with LA2015 and that as long as I remain a volunteer with LA2015, the criminal history records check and motor vehicle driving records check may be repeated any time. I understand that passing a background check is a condition of serving as a volunteer at LA2015 and voluntarily agree to this background check to be considered for a volunteer position at LA2015.

I hereby also authorize any person, business entity or governmental agency that may have information about me to disclose the information to the LA2015.

I WAIVE, RELEASE AND DISCHARGE LA2015, its officers, directors, employees, volunteers, agents and representatives from any liability for all damages and losses of whatever kind or nature that may result in connection with LA2015 conducting a criminal history records check or motor vehicle driving records check on me. I further waive, release, and discharge any person, agency, company, or organization from any liability for all damages and losses of whatever kind or nature that may result in connection with their disclosure of information about me.
