Upcoming ELL Board of Directors Elections

Elections for the 2018-19 Eastlake Little League Board will be held in-person at the Creekside Fields on May 19, 2018 and June 1, 2017. The polling station will be open from 9:00 a.m. to 4:00 p.m. both days.

Incumbent Board Members and new candidates must inform the Board of their candidacy between **now and May 12th by 12 pm, noon**. Ballots will be counted and notification of the new board members will be on June 3rd, 2018. The new board will officially take office on September 1, 2018.

Please make note of the following when submitting your candidacy:

- In order to efficiently track all submissions, notification of your candidacy must **ONLY** be made via email to **eastlakell@hotmail.com**.
- The email to the league may include a short bio no longer than 150 words about your connection to the league and desire to run Board position.
- After receipt of your email, within 24 hours, you will be sent a return confirmation that the league has received your submission.
- The date and time stamp of the email will record evidence of receipt by the league as it is received by the ELL Hotmail account.
- Names of all nominees will be posted on the website within 48 hours of submission. Please be sure to check www.eastlakell.teampages.com for your name.

NO nominations will be accepted **after** the **May 12th, 12 pm deadline**. If you have not notified the Board of your candidacy by this time, you will **NOT** be eligible to run.

Board membership is open to any member who is in good standing with the league and who lives in the Eastlake Little League district. All submissions are subject to review by the Eastlake Little League Board of Directors. Proof of residence will be required - per national Little League rules - and successful candidates will be subject to a background check.

NOTES:

1. To be eligible for election as ELL Board President, a Member must have served previously on the Board for a minimum of two years.
2. To be eligible for election as ELL Board Secretary, a Member must have served previously on the Board for a minimum of one year.
3. To be eligible for election as ELL Board Player Agent - A, a Member must have served previously on the Board for a minimum of one (1) term.
4. All positions listed above, with the exception of Vice President and Treasurer, will serve for a one-year term.
