I understand that accurate weight and height measurements, and knowledge of skiing ability are important to properly adjust the bindings on ski and snowboarding rental equipment (the "Equipment").

**Alpine Skiing:** I also understand that ski boot-binding systems will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and that the system is no guarantee that the user will not be injured.

**Snowboarding:** I understand that the snowboard binding system is not designed or intended to release and will not release under normal circumstances. I understand that as the snowboard binding system is a non-release system, it will not reduce the risk of injury during a fall.

I understand that the rental technicians are able to answer any questions as to the proper use of the Equipment.
