### Officials E-modules

Swimming Canada now offers the Chief Timekeeper as an E-modules through their Education website

Officials can sign in using the same username and password used for their official's account on the registration system. If an official has lost their login information or never received the email from [systems@swimming.ca](mailto:systems@swimming.ca), COAs can "resend" their login information using the Send Login Info feature:

From the COA account Click "Officials" then select official → click on

Send Login Info

When officials complete an e-modules, their online officiating profile is updated with the clinic details and an email is sent with details of the e-modules completed. Officials are encouraged to forward the email to their COA.

At this time, COA do not receive a notification when an e-module is completed by an official registered with their club. COAs can contact Nicole [nicole@swimontario.com](mailto:nicole@swimontario.com) for a report of whom has taken which e-modules.
