Time Trials Information

Date: Saturday, July 13th, 2019. Meet Begins at 9:00 am with warm-ups as noted.

Location: Tulare Union High School Pool. We will run eight lanes with warm-up / cool-down areas at the end of the pool. All teams have designated warm-up times. Swimmers will be allowed in the warm-up / cool-down area only for this purpose.

Rules: All CVRSL and USA Swimming rules govern the meet. All ages of swimmers will be staged. Prior to the estimated start of the event, swimmers should report to the staging area where they will be lined up for their events. The announcer will be broadcasting the upcoming events over the PA system. Please see the site map for the location of the staging area.

All Tulare Joint Union High School campuses are designated NON-SMOKING. Drugs, alcohol, and weapons of any kind are prohibited anywhere on campus. No glass is allowed. No dogs allowed on campus.

Missing Events: Any swimmer who has missed their scheduled event will not be allowed to swim their next event, as per CVRSL rules.

Fire Lane: The alley off Kern Avenue will have access limited to vendors, officials, unloading and the fire department. ***No parking will be permitted along the fire lane.*** Violators will be ticketed and/or towed at the owner's expense.

Tent City: Tent City is where swimmers families can set up camp for the day. Please refer to the site map for the Tent City location. Each swim club has been assigned a designated area that will be clearly marked with signs. Please be courteous to fellow swim families when setting up camps.

Time Trials Information (cont'd)

Parking: No vehicles or RVs will be permitted in Tent City. All vehicles, trailers, RVs not parked correctly will be ticketed per the Tulare Police Department and/or towed at the owner's expense. RV parking is on the street only.

Generators: *No generators allowed in Tent City or near the main pool area.* The best audio system has difficulty competing with the noise caused by generators so therefore swimmers are at risk of missing the calls for their events.

Spectator Area: There is limited bleacher seating. The spectator area is for observing a race only. This area will open at 8:30 am. Please rotate in and out of this area according to your swimmer's race to allow all spectators the opportunity to view their swimmer's races. *No camping will be allowed on or in front of the bleachers in the spectator area.* Therefore, umbrellas, chairs, and ice chests are not allowed in the spectator area.

Staging: Only those swimmers that have gone through the staging process will be allowed on deck. Please be sure to pay attention to the first and second calls in order to move your swimmers to the staging area in a timely fashion. See the site map for the entry into the staging area. Coaches will be permitted to ensure that their swimmers get on deck in the proper lane and in the proper order but must stand back before the start of the race. There will be no coaching from on deck.
