From the Managing Director

Welcome back to MSSAC. I would like to thank-you for continuing to choose us for programming for your swimmer(s).

Please read the registration package carefully. There are several changes to be aware of which include:

- We have changed to Team Unify and you will need to establish a new account.
- Your registration will not be approved until your current account balance is paid and you have registered for the group placement recommended by MSSAC staff.
- Please be aware of the fees approved at the AGM (increase of 5%).
- The Swim A Thon Fee has been combined with Program Fee. Only additional fees this year will be Swim Ontario, Lottery, and Points Assessment (Competitive programs). You may also choose to participate in additional programming (camps and clinics) that you will register for which will be an additional cost.
- Wave 2, Wave 1 and Swim for Fitness programs do not have any fundraising or lottery obligation.
- Wave 1 and Swim for Fitness are non-competitive programs, do not attend meets and will pay a non-competitive Swim Ontario Fee.
- There are changes to the refund policy and overdue account policy.
- There are additional fees for NSF \$50, Late Fees \$50, Administrative Changes \$50, Officials Volunteer Session Cancellations \$50.
- All families (White and Up) must volunteer 1 session at Hicken. Failure to do so will result in a \$75 additional charge.
- A mandatory requirement to have a saved Credit Card on file.
- The changes and additions to club policies. They are the following: Medical, Concussion, Safe Sport and Club Personnel Screening.
- The Team Unify Special Order item is the Team Track jacket. This is a one-time deal available in the fall only. Please watch the website for details.
- MSSAC Team Equipment and Uniforms are available only at Team Aquatic Supplies. The only item that can be purchased in the office is MSSAC caps.
- Members must submit a paper copy of Membership agreement to the office in addition to the online agreement.

Please remember that your registration and spot in the swim group is not 'official' until the MSSAC Registrar approves it.

Your previous year's account must be fully paid to successfully register for 2019-2020.

Season Start Information

SAVE THE DATE! Tuesday September 17th for our Annual Welcome Back BBQ at Huron Park.

The detailed practice schedule for September will be posted on the website. Please be aware that many pools shut down in September for maintenance so you may not follow your regular schedule the first couple of weeks.

Fundraising and Points Commitments

Fundraising helps make swimming more affordable for everyone. Volunteers make swim meets run and provide help where the club needs it. That's what our Points system was designed for.

Families will be required to fully participate in all Club-related fundraising activities which may include, but not be limited to, sales of products, lottery tickets, etc., from time to time during the swim season. Families are also required to attain a minimum number of 'points' for volunteer activities throughout the swim Season.

Your mandatory fundraising and volunteer points obligations are listed below. Your fundraising levy / Car Raffle will be billed on December 1st to your account and can be paid by the credit card saved on your account. Your points obligation has two deadlines. By February 1st you must have completed 50% of your points total. By the end of the season, the remainder. If by February 1st you have not made your obligation your account will be charged the full penalty. You will then have to the end of the season to complete the rest of the points commitment. If you do, we will credit your account the points penalty that we charged you. If you do not, the club will keep the money it collected on March 1st.

All families (White and Up) must volunteer 1 session at Hicken. Failure to do so will result in a \$75 additional charge.

This year we will be having a CASH prize for the lottery. Tickets will be provided in December 2019 and the draw will take place in June 2020.

You may sell your books of tickets or keep them for yourself, entering your name on each ticket. Given that you paid for the tickets up front, the cash you receive as you sell the tickets is yours to keep. All tickets must be returned to the Club before (details and reminders will be provided) to ensure that they are included in the draw. **We will supply each member with the raffle rules when we distribute the tickets.**

Swimmer's Code of Conduct

We must ensure that all swimmers are treated with respect and that we project a positive image. Swimmers are expected to adhere to the rules listed below while participating in any Club sponsored function including meets, practices, travel to swim meets and social activities. Failure to do so will result in disciplinary action, which could include suspension from the Club.

1. I will show respect for all athletes, parents, officials, coaches, pool staff and facilities at all times.
2. I will not use foul language.
3. I will not engage in any form of harassment against other athletes, coaches, parents or officials.
4. I will not engage in destructive gossip regarding coaches, staff, parents, athletes or officials.
5. I will not use banned substances, illegal drugs, and alcohol or tobacco products.
6. I will not break any laws.
7. I will not engage in any activities that could endanger or hinder other athletes or cause damage to property.
8. I will not leave practice or club functions without permission from the coach, official or chaperone.
9. I will wear MSSAC team attire as described in the Uniform Policy.
10. When travelling for meets, I will follow rules outlined by the coaches and chaperones. When the Coaches and chaperones deem behaviour unacceptable, I can be penalized, up to and including removal from the competition and being sent home at my family's expense. In extreme cases, dismissal from the Club could result. Internet Web sites, such as, but not limited to Facebook.com, Twitter and Instagram , on which people socialize and exchange information, shall not be used to post remarks or pictures that can be considered inflammatory, degrading, or in poor taste toward any other student athlete (MSSAC or otherwise), coach, or volunteer.

I am aware that failure to fulfill these obligations could result in dismissal from practices and/or meets, up to and including termination of membership.

Swimmer's Responsibilities

1. I will listen to my coach.
2. I will show respect for my coaches, team mates, parents, fans, pool staff and officials.
3. I will know my practice schedule and will be on time. This means being on deck 10 minutes before practice starts.
4. I will help with pool set-up and deck clean up as requested by my coach.
5. I will bring the required equipment to practice as outlined by my coach.
6. To avoid de-hydration, I will bring a bottle of water to practice and to meets.
7. I will maintain a healthy lifestyle, avoiding junk food and ensuring I get enough rest.

8. At swim meets, I am responsible for remembering which event/heat I am in, and will ensure that I get to that event a minimum of 5 minutes before the race begins.
9. I will have fun and promise to advise my coach or parents if this isn't the case.
10. I am representing the Mississauga Aquatic Club and will always support my team and be a positive role model.

Parent's Code of Conduct

MSSAC is committed to providing an environment in which all individuals (athletes, coaches and families) are treated with respect, and provides a supportive environment. As a result, parents/guardians are expected to adhere to some basic guidelines which are provided below.

1. I will conduct myself at all times in a manner consistent with the values of The Mississauga Aquatic Club, which include fairness, integrity and respect. This pertains to interaction with all athletes, other parents, officials and coaches.
2. I will refrain from comments or behaviours that are disrespectful, offensive, racist, abusive or sexist.
3. I will not engage in destructive gossip regarding coaches, staff, parents, athletes or officials.
4. If I have questions or concerns with respect to my child's swim program, I should contact my child's coach directly. Any further concerns will be directed to the Head Coach. If my concern is still unresolved, I will contact the Club President.
5. I will not approach coaches or officials on the swim deck during swim meets or during practices. Instead, I will arrange to meet with coaches before or after the sessions.
6. I will ensure that my child arrives at practice on time.
7. I will encourage a healthy lifestyle including nutritious foods and adequate sleep.
8. I will be supportive of my child and the team at all times, regardless of performance level.
9. I understand that volunteer organizations such as MSSAC depend on the energy and goodwill of parents to fulfill numerous essential roles. When I have an issue with my parent rep, meet technical organizers or board members, I will respect that these are all volunteers working on my child's behalf. If I feel the need to take issue with any member of our "team", I will do so privately and directly with the people involved. If resolution is not achieved, I will contact the Club President.
10. I will ensure that my swimmer understands that Internet Web sites, such as, but not limited to Facebook.com on which people socialize and exchange information, shall not be used to post remarks or pictures that can be considered inflammatory, degrading, or in poor taste toward any other student athlete (MSSAC or otherwise), coach, or volunteer.
11. I will support my swimmer and the Club by volunteering my time to assist in meets, social events and fundraising activities.

I understand that failure to comply with these Codes may result in disciplinary action as determined by the Board of Directors, up to and including termination of membership.

PIPEDA Policy

PIPEDA regulates the collection, use and disclosure of personal information. Swim Ontario has developed a policy on the collection, use and disclosure of personal information. We follow this policy.

The Swim Ontario policy is available via MSSAC's website (www.mississaugaswimming.com) or Swim Ontario's website (www.swimontario.com). Swim Ontario has access to all personal information collected by MSSAC.

Photo Policy

In the course of the swimming season, pictures and videos may be taken to promote the Club or to use as training materials. Most common uses are advertising material, publication on our website, displays at sports shows and our Awards Banquet, and for training purposes. We love to include parents/guardians in our event pictures as you're as much a part of the Club as your children!

By joining MSSAC, you are providing permission (on behalf of your child/ward), to the Mississauga Aquatic Club to photograph and/or record your child/ward and or your child's/ward's voice, in still photographs, video and/or audio tape and to use this material, in whole or in part, through the media of television, internet, multi-media presentation, radio, or in a printed form or display for the promotion or as part of the Mississauga Aquatic Club, or to create training materials for use by the Club.

Medical Policy

Any swimmer with an injury preventing him/her from full program participation must submit a Doctor's note. As soon as the swimmer is able to participate either partially or fully another note must be submitted approving the return to the pool along with detailing any restrictions. Doctor's note which must be submitted directly to susanne@mississaugaswimming.com

Concussion Policy

If a swimmer has been identified as having a suspected concussion, it is the responsibility of coach, administrator and/or supervisor of that activity to notify all affected parties including the swimmer parent/guardian (when appropriate) as well as other coaches, administrators and/or supervisors of the suspected concussion. At this point the swimmer should not participate in any physical activity until he/she has visited a medical doctor.

If a concussion is suspected, please be safe and consult a physician as soon as possible. Once diagnosed, concussion recovery varies considerably for athletes and is influenced by many factors. A licensed sport medicine practitioner or doctor, with experience in the areas of concussion management and treatment should guide all return to swimming decisions. The responsibility rests with the athlete, their caregivers/ parents, and MSSAC to ensure that there is no swimming until medically cleared to do so by their medical practitioner/ doctor.

SAFE SPORT Policy

MSSAC's safe sport policy will follow Swimming Canada's safe sport policy.

MSSAC provides a fun, healthy, inclusive and safe environment. Swimming enriches the lives of everyone involved by ensuring that the training and competitive environment is one where athletes, coaches, officials and volunteers know they are safe, and are treated with respect and dignity.

We believe that everyone in the sport has the right to enjoy swimming at whatever level or group they participate. Athletes, coaches, officials and volunteers have the right to participate in a safe and inclusive training and competitive environment that is free of abuse, harassment or discrimination.

MSSAC believes the welfare of everyone involved in the sport is a foremost consideration and in particular the protection of children/athletes in the sport is the responsibility of each individual, member and special interest group in the swimming community.

Club Personnel Screening Policy

MSSAC has a duty of care to protect and not place at unreasonable risk its swimmers. Working with vulnerable people, we assume the responsibility of screening personnel and volunteers. We follow the Swim Ontario screening process to identify and minimize the risk of an unsafe environment for our swimmers while interacting with paid, unpaid, volunteers and/or staff at the pool, at competitions, during travel and in other club activities.

Team Uniform Policy

Regardless of the program, all MSSAC swimmers are expected to come to practices with the following: swim suit, goggles and official MSSAC swim cap. We have a contract with ARENA so all suits and equipment (goggles, fins and kickboards etc.) should be ARENA.

Our team wear provider is Team Aquatic Supplies (TAS) <https://team-aquatic.com>. MSSAC has group discounts with TAS and in support of the agreement, all members must purchase team wear, including competition suits from TAS.

For 2019/2020 MSSAC has partnered with TAS and Arena to bring MSSAC members new and exciting team wear items. **This year the MSSAC Team Wear discounted item is the team Track jacket and will be available ONE TIME during the year to club members.** This way MSSAC members will receive the lowest price possible. If your swimmer needs to be fitted for any of the Custom MSSAC team wear you will need to go to TAS in Mississauga.

All swimmers in White and above must have the team track jacket so please take advantage of the discount in the fall order. Further information can be found on the club's website.

Meet Fees

A detailed Meet Schedule will be available on the website.

MSSAC pays in advance for your swimmer to participate in swim meets. You will be billed for your swimmer's meet fees separately from your program fees and fundraising levy. You pay for the events that your swimmer is entered as well as the shared team costs associated with the swim meet.

If your swimmer is ill or injured and does not participate in the meet, you must still pay the meet entry fees. NO EXCEPTIONS.

For travel meets, you will be contacted by the Club via email to confirm participation. Travel meets are handled this way due to cost. The lead time to confirm participation in travel meets is generally further in advance so that we may finalize travel arrangements. If your account is in arrears you will be asked to bring your account current prior to a travel meet. All paperwork and travel deposits MUST be submitted and processed prior to your child being accepted on a travel team. There will be NO exceptions to this policy.

Please be aware that advising our office staff is not the correct method to confirm participation or to withdraw from a meet. Contact your swimmer's coach by email and cc the meet entries coach nandi.kormendi@mississaugaswimming.com.

The annual fees for each program are outlined below. *Note that fees do not correspond to a fixed number of hours or practices per week/season. Some practice times will change depending on pool availability, meets, training camps and coaching availability.

Note:

1. This schedule does not include the mandatory MSSAC Team Uniform costs. All swimmers receive one MSSAC latex swim cap in MSSAC competitive programs.
2. This schedule does not include your swimmer's meet fees (estimated \$0 - \$2,000+), shared team costs, travel, special teams or training camps.
3. This schedule does not include the Swim Ontario Fee. This is a separate charge when you register.

Additional Swim Ontario Fee

These fees (which are mandatory, provide provincial programming and insurance) are as follows for **competitive** programs:

◆ Ages 8 and Under	\$ 121.40
◆ Ages 9 and 10	\$ 141.40
◆ Ages 11-14	\$ 161.40
◆ Ages 15 and Over	\$ 181.40
◆ Open-Varsity	\$ 52.28

Non-competitive programs: \$ 52.55

*This fee is based on the swimmer's age as of December 31st, 2019.

Payment Schedule

You may pay your program fees by making one payment or selecting to have your credit card automatically charged on the first of every month for the program installment fees. All program installment fees, meet fees, lottery levy and Swim Ontario fees will be charged to the credit card saved on your account. The lottery levy will be charged December 1st. The Swim Ontario fee will be charged upon registration and approval by the club Registrar, Susanne Scamurra.

Outstanding balances are not carried forward from year to year. They must be paid in full either before AUGUST 15th of each year or upon registration.

We ask that your account never be in arrears. Failure to pay according to the schedule will result in suspension from the meets, from practice or dismissal from the Club.

***Pro-rated fees for late registrations:** 100% before December 31st, 70% Jan.1 – Mar.31, 50% April-May 31.

***Fee adjustments for swimmers moving to a different group:** The membership fee will be adjusted based on the previous and new group fee in the month which the group move takes place.

***Sibling Discount:** Sibling discounts will be applied against each program fee payment and are as follows: 10% off 2nd family member, 15% off 3rd family member, 15% off 4th family member.

*Swim Ontario Fee is only paid once per season per athlete

Please note that MSSAC remits the Swim Ontario Registration fee to the provincial office on behalf of all members in September. **The Swim Ontario Registration Fee is not refundable once remitted to the Swim Ontario office.**

Other Administration Charges

Note that a fee of \$50.00 will be charged to your account for each rejected/ denied credit card payment (that is billed on the 1st of the month). There will be no exceptions to this policy. This will appear as a “late fee” and be charged on the 21st of the month.

An Administration Fee of \$50 will be applied to ALL TRANSFERS and CANCELLATIONS.

Officials and Volunteer Sessions Cancellation Policy

MSSAC hosts meets to provide racing opportunities to our swimmers and to be part of the swimming community for the shared goal of racing. MSSAC also relies on the meets it hosts to provide revenue.

Volunteer participation and planning are key to the success of our hosted meets. Once the cancellation deadline has passed for volunteers the Officials grid will be ‘locked’ and you will be charged a fee of \$50 per missed or cancelled work sessions. NO EXCEPTIONS.

No Refunds Policy

MSSAC has a NO REFUNDS POLICY. Refunds will only be given if program fees are paid in FULL.

The schedule is as follows: 60% October 31st, 40% November 30th, 20% December 31st, After December 31st 0%. (FEES PAID IN FULL ONLY)

There is not a refund for fees paid by the payment/ instalment (six) plan. NO EXCEPTIONS.

Members who fall into arrears and/or do not respond to requests for payment, will have their swimmer suspended from practices and/or meets. We hope that members understand that the Club has a fiduciary responsibility to ensure that everyone is in good financial standing.

Overdue Account Policy

The system will generate an automated message for accounts overdue at 21 days. At this point in time a late fee will be applied. After 30 days the swimmer(s) will not be able to register for meets. After 60 days the swimmer will be suspended from practice.

Resignation Policy

Any swimmer resigning from the club must provide written notice to the club office. Please email Susanne Scamurra, Club Registrar, susanne@mississaugaswimming.com.

Registration Process

1. Click on the registration link and establish your account. We have moved back to Team Unify. You are responsible for ensuring your contact information is up to date.

Up to 4 other emails can be added to receive email updates

2. Register.
3. Print, sign and scan or drop off a copy of the Membership Agreement to the office.
4. Receive confirmation of approval by Club Registrar, Susanne Scamurra.
5. In September check your email for notification from Swimming Canada. You **must** verify the account for swimmer information accuracy. If you do not, your swimmer will not be insured.
6. In September complete your Officials registration. You **must** verify the account by clicking on the link and following the instructions.

Forms and Information that must be submitted to the club office

After completing the on-line portion of the registration package, the Registrar will approve the registration and move your swimmer to the correct roster group. You will receive an email with your swimmer(s) group placement information and confirmation. You must provide a paper copy of your Membership Agreement to the office either by printing, signing and scanning it or by dropping it off at the office.

It is very important that you read the entire registration package and understand all the club policies in this document. The online system requires you to agree to a membership agreement which confirms that you have read and understand the policies and membership terms that you and your swimmer will have to abide by.

Membership Terms

By registering with Mississauga Aquatic Club, you acknowledge that:

Swimming, like any sporting event, may present various elements of risk. I do hereby for and on behalf of myself, my heirs, executors, administrators, and assigns, remise, release and forever discharge The Mississauga Aquatic Club, its officers, members, representatives and agents, and their heirs, executors, administrators, successors and assignees, of and from any and all damages, losses and injuries which may be suffered or sustained by me or my son/daughter or ward in connection with practices and swim meets, and travel to/from swim meets, and all such causes or action, claims and demands are hereby waived.
