COVID-19 RELEASE AND WAIVER**

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS. PLEASE READ THIS DOCUMENT CAREFULLY BEFORE ACCEPTING.

FOR ANY PARTICIPANT WHO IS NOT YET 18 YEARS OLD, THESE TERMS AND CONDITIONS MUST BE READ AND ACCEPTED BY THE LEGAL GUARDIAN OF THE PARTICIPANT. By signing below, I hereby verify that, as legal guardian of the participant, I have read and fully understand each of the following terms and conditions for permitting my child to participate, and I accept each of the terms and conditions below on behalf of my child.

SBCCD urges you to consult publicly available information, such as that provided by the Centers for Disease Control, “CDC,” and/or local governmental agencies, “DPH”, so that you can make your own independent judgment as to the degree of risk that you will be undertaking, should you decide to engage in aquatic activities, included but not limited to swim team practice, water polo, lap swim, water exercise, etc, (collectively “aquatic activities”). I acknowledge and understand that the DPH and CDC guidelines are regularly modified and updated, and I accept full responsibility for familiarizing myself with the most recent updates.

This release and waiver applies to SBCCD Aquatic Activities and related activities. The SBCCD swimming pool will only open as long as the DPH is allowing public swimming pools to remain open. Of course, that does not mean that participating in Aquatic Activities is free from the risk of contracting COVID-19 as a result of your participation in Aquatic Activities.

As a condition to permitting you to participate in any activity at SBCCD, you agree as follows:

- The undersigned acknowledges, appreciates, and agrees that there is a risk of contracting the COVID-19 virus as a result of my participation in Aquatic Activities at SBCCD, that the disease COVID-19 is serious and could result in my death, and that such risk cannot be eliminated.
- The undersigned acknowledges and agrees that SBCCD has not independently assessed the risk of my contracting COVID-19 while participating in Aquatic Activities or undertaken any duty to minimize that risk.
- Notwithstanding the foregoing, the undersigned knowingly and freely assumes all risks associated with the undersigned’s participation in Aquatic Activities at SBCCD and other activities related thereto.
- The undersigned hereby releases: (a) SBCCD, and (b) the officers, directors, agents, employees and independent contractors of SBCCD (the parties referred to in sections (a) and (b) of this paragraph being collectively referred to as the “Released Parties”) from any and all claims, actions, causes of action and liabilities, whether known or unknown, suspected or unsuspected, of every nature whatsoever that I have, or may have, now or in the future, relating to my having contracted the COVID-19 virus as a result of my participation in any activities at any facility SBCCD operates.
